Dear Senator Frist:

We want to express our support for increasing the indirect medical education (IME) payments to teaching hospitals within the Medicare bill.

Teaching hospitals will lose an estimated \$794 million in IME payments in FY 2003 alone, and will lose \$4.2 billion over the next five years. In 2003, Tennessee teaching hospitals will lose \$42 million, Louisiana and Arizona - \$7 million each, Oklahoma - \$5 million and Iowa - \$4 million due to the reduction. Teaching hospitals have a unique characteristic - - they are responsible for training all of our nation's physicians and, due to this position, their costs are greater than other hospitals. Every state has at least one teaching hospital, with 1,100 facilities nationwide. Teaching hospitals train nearly 100,000 physicians annually, and the federal government has recognized the higher costs inherent in training and educating those health care providers by reimbursing the hospitals through IME payments.

Furthermore, teaching hospitals provide state-of-the-art and essential services and clinical care, such as burn and trauma care, and bone marrow and organ transplants. In fact, in many states, teaching hospitals are the only providers of such critical services. Because major teaching hospitals are in financial distress, we are concerned that these services could be compromised if IME cuts are not reversed.

The Senate-passed Medicare bill includes an IME provision, increasing payments by approximately .03 percent over ten years, which was a place holder. In order to continue quality physician education, teaching hospitals will require, and we would like to see, IME payments increased by one percent; to 6.5 percent over ten years. The House-passed Medicare bill does not provide any relief in the bill. We appreciate Sens. Frist, Grassley, Santorum and Baucus agreeing to include a modest amount of IME relief in the Senate bill while committing to increase the IME adjustment in conference.

We look forward to working with you to ensure our nation's teaching hospitals can continue to train the physicians of the future while providing superior care. Thank you for your consideration.
