The Rural Health Network Development (RHND) Program provides funding to support activities that strengthen the organizational capabilities of rural health networks. The program is designed to support organizations that wish to further ongoing collaborative relationships to integrate systems of care administratively, clinically, financially, and technologically. The ultimate goal of the Program is to strengthen the rural health care delivery system by improving the viability of the individual providers in the network, and/or improving the delivery of care to people serviced by the network.

This new Network Development Planning Grant Program provides one year of funding to rural communities that seek to develop a formal integrated health care network and that do not have a significant history of collaboration. The planning grants are to be used to develop a formal network with the purpose of improving the coordination of health services in rural communities and strengthening the rural health care system as a whole. Existing networks that seek to expand services or expand their service area are not eligible to apply.

SHCPQI will focus on quality improvement for chronic diseases, i.e., diabetes mellitus and cardiovascular disease.

Telehealth Networks TNGP-TH Grants made under this provision will support telehealth networks that provide services in different settings e.g., long-term care facilities, community health centers or clinics, physician offices, hospitals, schools, assisted living facilities, homes. More specifically, the networks can be used to: (a) expand access to, coordinate, and improve the quality of health care services; (b) improve and expand the training of health care providers; and/or (c) expand and improve the quality of health information available to health care providers, patients, and their families. The primary objective of the Telehealth Network Grant Program (TNGP) is to help communities build the human, technical, and financial capacity to develop sustainable telehealth programs and networks. In 2003, 15 projects were funded through the TNGP as part of a three-year award.
