#### **RICK W. MERRILL, TO LEAD AHA'S SECTION FOR MATERNAL AND CHILD HEALTH**

WASHINGTON — Rick W. Merrill, president and CEO of Cook Children's Health Care System in Fort Worth, Texas, is the 2013 chair of the American Hospital Association's (AHA) Section for Maternal and Child Health. The governing council is a 15-member body comprised of CEOs and senior executives from the nation's women's and children's health care providers. As chair, Merrill will lead the section's governing council on public policy issues concerning women's and children's health, hospitals serving that patient population and AHA member service strategies.

Merrill has more than 27 years of health care management and leadership experience, serving the past five years at Cook Children's Medical Center. Merrill led the historic expansion of Cook Children's Medical Center, which nearly doubled the size of the campus to respond to the growing need for its services. In addition under Merrill's leadership, Cook Children's began a new era by streamlining its mission and vision into a promise to improve the health of every child in the region through the prevention and treatment of illness, disease and injury.

Prior to joining Cook Children's, Merrill served as the president and CEO at Driscoll Children's Hospital in South Texas for eight years. Before joining Driscoll, he served as Administrator/Chief Operating Officer at Medical City Dallas and as senior executive vice president/Chief Operating Officer at Hillcrest Health System in Waco, Texas.

Merrill has worked in leadership roles in for-profit, not-for-profit and academic health care facilities.

Merrill actively serves on numerous national, state and community advisory boards; most recently, as chair for the Dallas-Fort Worth Hospital Council.

A Texas native, Merrill received a Bachelor of Science from Texas Tech University and a Master of Science in health care administration from Trinity University.
