

Chair-Officers**Brian G. Donley, M.D., Council Chair
Chief Executive Officer, Cleveland Clinic London, England
(Term 2017-19; Chair Officer 2019-21)**

Brian is chief executive officer of Cleveland Clinic London, a role he began in February 2018. As CEO, Brian directs the strategy and operations, guides recruitment and will lead the opening of an outpatient medical facility in 2020 and a new 184 bed private healthcare facility in central London near Buckingham Palace in early 2021. The full service facility will add another international location to a health system that includes a 165-acre main campus near downtown Cleveland, nine regional hospitals throughout Northeast Ohio, and facilities in Florida, Nevada, Canada and Abu Dhabi.



Since joining Cleveland Clinic as an orthopedic surgeon in 1996, Brian has held numerous leadership positions within the Cleveland Clinic health system. Brian established and chaired the Cleveland Clinic's Professional Conduct Committee. He served as President of Lutheran Hospital, President of the Cleveland Clinic Regional Hospitals and Family Health Centers and, in January 2015, Brian began his role as Chief of Staff and Chief of Clinical Operations for the Cleveland Clinic Health System overseeing all clinical operations across North America and leading the more than 4,000 physician medical group.

Brian is a professor of surgery at the Cleveland Clinic Lerner College of Medicine and has published numerous peer reviewed articles and book chapters in addition to holding multiple patents for innovative orthopaedic foot and ankle medical devices. Brian graduated Phi Beta Kappa from the University of Notre Dame; completed his medical and orthopaedic surgery training at the University of Michigan Medical School; and completed the Advanced Management Program at Harvard Business School.

**Penny Wheeler, M.D., Council Chair-elect
President and Chief Executive Officer, Allina Health, Minneapolis, MN
(Term 2017-20; Chair Officer 2021-22)**

Penny became the president and chief executive officer of Allina Health in 2015. She previously served as chief clinical officer since 2006 and president since 2013. Allina Health is comprised of 12 hospitals, 90+ clinics, 29,000+ employees and several related companies including home health, hospice, transportation, medical equipment and retail pharmacy. Penny sets the overall strategic direction for Allina Health, focusing on ensuring the organization delivers exceptional care and supports the health and well-being of all those served. She is a board-certified obstetrician/gynecologist.

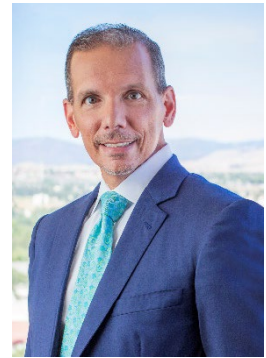


Under Penny's leadership, Allina Health has sharpened its focus on serving those who have not always been well-served by the health care system, including individuals with disabilities through the creation of Courage Kenny Rehabilitation Institute; those with mental illness and addiction issues through significant investments in Allina Health's mental health capabilities; and those at the end of life through innovative approaches which allow patients in late life to focus on what matters most. In addition, she led the creation of Allina Health's clinical service line model which helps ensure patients receive the right care at the right place at the right time. Penny has led care coordination and navigation efforts, payer partnerships to advance outcomes-based reimbursement models, and championed the use of advanced analytics.

Penny is on the board of Portico Healthnet, an organization dedicated to helping uninsured Minnesotans receive affordable health coverage and care, the Greater Twin Cities United Way, St. Thomas University and the University of Minnesota Foundation. Additionally, she chaired the board of the Minnesota Community Measurement, a regional health quality collaborative. *Minnesota Business* named Penny the 2012 "Outstanding Health Care Executive" and *Modern Healthcare* recognized her in 2015 as one of the "Top 25 Women in Health Care." In July 2015, Minnesota Governor Mark Dayton appointed her to the Taskforce for Health Care Financing. In 2018 she received an award as one of the 100 most influential people in healthcare and in 2019 was recognized as one of the 50 most influential clinical executives.

**Anthony (Tony) Slonim, M.D., Dr.PH, FACHE, Council Past-Chair
President and Chief Executive Officer, Renown Health, Reno, NV
(Term 2017-19; Chair Officer 2018-20)**

Tony is the president and CEO of Renown Health, an integrated healthcare system including five acute care campuses; 120 sites for primary, urgent and specialty care; affiliations with Stanford Medicine, the University of Nevada, Reno Medical School, St. George's University School of Medicine in Grenada; and an integrated, provider-sponsored health plan that serves more than 160,000 members. Renown's more than 7,200 employees and 1000 providers serve as the regional referral center for 100,000 square miles from Sacramento to Salt Lake City.



With a focus on caring for patients, members, and the community, Tony has a personal passion for population health. He caught the industry's attention by launching the Healthy Nevada Project®, the first community based, population health study combining genetic, environmental, social and clinical data to address individual and community health needs. As of January 2020, nearly 50,000 volunteer participants have enrolled in this program statewide and it has become a model for genetic screening at the population level nationwide. Governor Steve Sisolak recently appointed Tony as a Commissioner on the Patient Protection Commission, responsible for improving access, affordability and quality of healthcare for all Nevadans.

Recognized nationally as a thought leader, *Modern Healthcare* has named Tony to its Most Influential Physician Executives and Leaders list. He has been honored on *Becker's Hospital Review's* "Physician Leaders to Know" list since 2014. Tony serves as the inaugural editor-in-chief of the American Association of Physician Leader's (AAPL) *Physician Leadership Journal* serving the needs of the 15000 physician leaders who subscribe to this bi-monthly publication. Tony recently completed his term as chair of the AHA's Systems Council.

Tony graduated from New York Medical College, served four years in the U.S. Public Service Commissioned Corps, and earned both his master's and doctoral degrees in health policy from The George Washington University's Center for Health Policy Studies.

The Division includes HealthONE in Denver and Wesley Healthcare in Wichita, and consists of nine acute care hospitals, a rehabilitation hospital, a behavioral health and wellness campus, nine freestanding emergency departments, 20 ambulatory surgery centers, dozens of physician clinics and six urgent care clinics. Before this appointment, Sylvia served as president of HCA's Sunrise Health System; chief executive officer of The Medical Center of Aurora and Centennial Medical Plaza; and as chief operating officer of HealthONE's The Medical Center of Aurora.

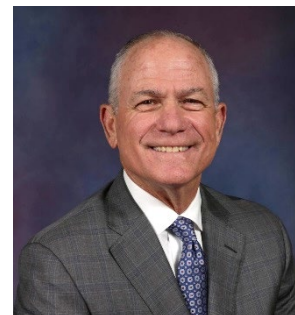
Sylvia has a master's degree in health administration from the University of Alabama, Birmingham and a bachelor's degree in public administration from Samford University in Birmingham.

David has served as president and chief executive officer of Select Medical Corporation since January 2014. Prior, he served as the company's president from 2010-14; held the additional titles of chief administrative officer in 2012-13; chief development and strategy officer in 2011-12; and chief strategy officer in 2010. He previously served on the Company's Board of Directors from August 2005 to September 2010.



Select Medical began in 1996 as a regional provider of outpatient physical rehabilitation. Today, it is listed on the New York Stock Exchange, currently trading under the NYSE ticker symbol SEM, and encompasses four areas of patient care expertise: critical illness recovery (LTACs), inpatient medical rehabilitation, outpatient physical therapy and occupational medicine, all of which are delivered and supported by more than 49,000 health care professionals across the U.S. Through valued partnerships with health systems nationally, Select Medical has grown to become the largest provider of post-acute care across the U.S. with over \$5 billion in sales, making them a Fortune 500 company.

Prior to joining Select, David served as the president and chief executive officer of Oncure Medical Corp., a national network of cancer treatment centers; president and chief executive officer of JA Worldwide, formerly known as Junior Achievement;; and president of the Physician Services Group at US Oncology, Inc. David co-founded American Oncology Resources in 1992 and served as its chief development officer until the time of the merger with Physician Reliance Network, Inc., which created US Oncology, Inc. in 1999.

Russ assumed his current position as president and chief executive officer of Norton Healthcare in January 2017. He joined Norton Healthcare in September 2000 as vice president of support services. He was appointed senior vice president, operations and development, in October 2002; executive vice president in September 2004; and executive vice president and chief operating officer in September 2005. Norton Healthcare includes five large hospitals, 14 Norton Immediate Care Centers, 5 diagnostic centers and more than 270 physician practice locations.



Prior to joining Norton Healthcare, Russ spent six years as executive director of resource operations at Caritas Health Services in Louisville. Liz developed and provides continued oversight of strategic priorities, with a focus on clinical excellence, top value, community wellness and high engagement to lead PeaceHealth from an acute care, hospital-centric model of care to a person-centered and community care model. With a strong focus on community partnership and increasing access to care, Liz led PeaceHealth's acquisition of ZOOM+Care in 2018.

Liz came to PeaceHealth in 2015 from Providence Health & Services, where she served as community chief executive officer for the South Bay (Calif.) Region, with direct oversight for two hospitals and six care sites in Torrance and San Pedro. She previously held executive officer positions with City of Hope (Duarte, Calif.) and Memorial Health Services (Fountain Valley, Calif.).

Chief Executive Officer, Hackensack Meridian Health, Edison, NJ
(Term 2018-20)

Bob is chief executive officer of Hackensack Meridian Health, New Jersey's largest health network with 17 hospitals from Bergen to Ocean counties, with 4,500 beds, 6,500 credentialed physicians, more than 500 patient care locations and 34,100 team members. Under Bob's visionary leadership, the network opened the Hackensack Meridian School of Medicine at Seton Hall University, formed a historic partnership with Memorial Sloan Kettering Cancer Center and secured the network's merger with New Jersey's largest behavioral health provider to dramatically improve access and the quality of care for addiction treatment and mental illness in New Jersey and beyond. The School of Medicine's campus is also home to the Hackensack Meridian Health Center for Discovery and Innovation, which attracts leading researchers from around the globe who are advancing knowledge of regenerative medicine, cancer and infectious disease and multiple myeloma.



Bob launched his career at Hackensack University Medical Center in 1981. He served as president and CEO of the Hackensack University Health Network from 2009-2016, dramatically expanding the network through a series of acquisitions, partnerships and affiliations. In July 2016, the network merged with Meridian Health creating Hackensack Meridian Health with an extensive breadth of services reaching two-thirds of New Jersey residents.

Bob's leadership and strategic vision has garnered much professional praise. He has been included in the prestigious list of The CEO Forum's 10 CEOs Transforming Healthcare in America. He is a national and international thought leader on transformation and innovation—ranking in *Fortune's* Top 50 World's Greatest Leaders in 2019. He also ranked second among *Modern Healthcare's* Most Influential Physician Executives and Leaders and tied for second on its list of the 100 Most Influential People in Healthcare in 2018.



He is leading Intermountain's 38,000 employees to embrace bold new approaches to improve health, re-define value-based care, and serve people in new ways. For example, Intermountain launched Civica Rx, a not-for-profit generic drug manufacturer and distributor, to make generic medications more available and affordable in hospitals across the nation. Lydia had served as the interim president and CEO from May 2017 through October 2017.

Lydia joined SCL Health as senior vice president and chief financial officer in June 2010, with responsibility for all financial and accounting functions as well as supply chain and real estate for the health system, ensuring the security, stewardship and growth of the system's financial resources. She played an instrumental role in the development of organizational financial policies and directed the financial reporting system responsible for producing timely and accurate data. Sarah oversees Sutter's integrated network of 14,000 clinicians, 24 hospitals, outpatient services, research facilities, and home health and hospice care.

Sutter Health has been recognized by independent organizations as a national leader in healthcare quality and advancing health equity. True to its not-for-profit mission, Sutter also provides compassionate care for more low income Medi-Cal patients than any other health system in its Northern California footprint.



Sarah has dedicated her healthcare career to finding ways to make healthcare more safe, personal, affordable and accessible. In the beginning of her career, Sarah was a caregiver for the elderly and people with severe mental illness, where she saw firsthand the impact of our broken system on patients.

Sarah was named Sutter Health's president and CEO in January 2016. Prior to this role, she served as Sutter's chief operating officer, regional executive officer and president of the Sutter Health Sacramento Sierra Region, and senior vice president of managed care. Previously, Sarah held executive roles at Kaiser Permanente and served as deputy director of Maine's Bureau of Medical Services and acting director of Medicaid health planning and licensure programs.

Jon is currently the executive vice president for health affairs at Emory University; executive director for Emory's Woodruff Health Sciences Center, and the president, CEO and chair of the board of Emory Healthcare. He also serves as professor of radiology and imaging sciences, professor of biomedical engineering, and professor of health policy and management. Emory Healthcare offers patients and families the choice of more than 2,800 physicians and 250 locations, including 11 hospitals. It is the only health system in Georgia with three Magnet-designated hospitals for nursing excellence.



Prior to his Emory appointment, Jon served as senior vice president for integrated healthcare delivery and as co-chair for strategic planning for Johns Hopkins Medicine. He was also professor and chair of the Russell H. Morgan Department of Radiology and Radiological Science at Johns Hopkins University and radiologist-in-chief at Johns Hopkins Hospital, with secondary appointments as professor of oncology, neurosurgery and biomedical engineering. Jon was the Director of the Division of Magnetic Resonance Imaging at University Hospitals of Cleveland and Professor and Vice Chairman for Research and Academic Affairs in the Department of Radiology at Case Western Reserve University.

Jon has been a pioneer in interventional and intraoperative MR imaging and has published more than 250 peer-reviewed scientific manuscripts and 60 book chapters, reviews, commentaries and other invited papers. Steve assumed the role of president and chief executive officer of OhioHealth in July 2019, self-described as a family of 29,000 associates, physicians and volunteers, and a network of 12 hospitals, 200+ ambulatory sites, hospice, home health, medical equipment and other health services spanning 47 Ohio counties.

Steve also served as president of OhioHealth Riverside Methodist Hospital and before that held a variety of roles at Riverside Methodist, including chief operating officer, vice president of clinical services, associate medical director, and associate and assistant director of the Family Practice Residency program. A National Institutes of Health (NIH)-funded researcher and award-winning educator, he also served as Professor and University Chairman of Pediatrics at Albert Einstein College of Medicine and Physician-in-Chief of Children's Hospital at Montefiore (CHAM).

In these roles, Dr. Ozuah expanded access for underserved communities, recruited and cultivated outstanding talent, advanced programs of excellence, fostered innovations in medical education, and improved financial and operational performance by integrating care across a rapidly growing and evolving Montefiore system that sees over six million patient interactions a year. 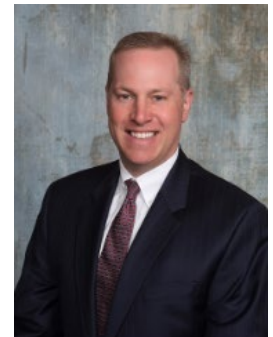
