Legislative and Regulatory Updates

Webinar tomorrow: AHA Advocacy Alliance for Rural Hospitals' federal update on COVID-19 AHA's Advocacy Alliance for Rural Hospitals May 1 at 2 p.m. ET will host a federal update for rural hospitals on which AHA leaders Travis Robey, senior associate director of federal relations and Erika Rogan, senior associate director of payment policy, will discuss COVID-19-related issues specific to rural hospitals and health systems. They will focus on AHA's legislative and regulatory efforts to support rural hospitals during the ongoing pandemic, including a discussion of our priorities for the next COVID-19 relief package and an overview of the bills and regulatory action already taken to help rural providers. Among the issues they will discuss will be AHA's efforts to make improvements to the Medicare Accelerated and Advance Payment Programs; the Small Business Administration Paycheck Protection Program loan program; telehealth rules; ongoing efforts to address equipment shortages; and the likelihood of other rural legislative priorities being considered this Congress. AHA-supported bill would extend COVID-19 telehealth expansion to additional providers Reps. Cynthia Axne, D-lowa, Troy Balderson, R-Ohio, and French Hill, R-Ark., April 24 introduced the Emergency COVID Telehealth Response Act, legislation that would extend the Department of Health and Human Services' waiver authority for telehealth services to include physical therapists, occupational therapists, speech language pathologists and certain other providers during the COVID-19 emergency. The agency last month used its waiver authority to broaden access to telehealth services for Medicare beneficiaries during the emergency.

Funding Opportunities

The Health Resources and Services Administration is accepting applications for new funding opportunities:

- Nurse Education, Practice, Quality and Retention Simulation Education Training Program, which expands the use of simulation-based technology and observational learning opportunities for nursing students, is making available approximately \$2 million for fiscal year 2020 to fund four cooperative agreements. Apply by June 1.
- Nursing Workforce Diversity-Eldercare Enhancement (NWD-E2) Program will issue two
 awards from a \$1 million FY 2020 pool to programs that help provide advanced geriatric
 education and training opportunities for underprivileged nursing students Apply by June 4.
- Advanced Nursing Education Nurse Practitioner Residency Integration Program, which
 prepares new primary care or behavioral health nurse practitioners to work in integrated,
 community-based settings, is making available for five FY 2020 awards approximately \$5
 million. Apply by June 8.

The National Health Service Corps understands the COVID-19 outbreak has a direct impact on academic institutions and students, so:

- The NHSC Scholarship Program application deadline has been extended to May 15
- The NHSC Loan Repayment Programs deadline has been extended to May 21.
