## REGINALD COOPWOOD, M.D., TO CHAIR AHA'S METROPOLITAN HOSPITALS GOVERNING COUNCIL

**WASHINGTON** – January 24, 2014 – Reginald Coopwood, M.D., president and CEO of Regional Medical Center at Memphis, will lead the American Hospital Association's (AHA) Section for Metropolitan Hospitals as chair of its 24-member governing council for 2014. The section is a forum for suburban and urban hospitals to discuss common interests and concerns and to participate in the AHA policy process.

Prior to joining Regional Medical Center in March 2010, Dr. Coopwood was the CEO of the Metropolitan Nashville Hospital Authority. A board-certified surgeon, Dr. Coopwood served as associate clinical professor of surgery at Vanderbilt University School of Medicine and associate professor of surgery at Meharry Medical College.

Dr. Coopwood's work at Regional Medical Center is complemented by his commitment to the health and well-being of the individuals in the Memphis community. He chairs the boards of the Tennessee Hospital Association and the MidSouth e-Health Alliance and sits on the boards of Blue Cross Blue Shield of Tennessee, the Memphis Chapter of the March of Dimes and America's Essential Hospitals. Dr. Coopwood is also a member of the UTHSC Chancellor's Advisory Board and an alumnus of Leadership Memphis.

Dr. Coopwood received his medical degree from Meharry Medical College in 1985, followed by his general surgical residency in 1990. Wright L. Lassiter III, CEO of Alameda Health System in Oakland, Calif., is this year's chair-elect and will assume the role of chairman in 2015. Douglas Duchak, past president and CEO at Englewood Hospital and Medical Center, Englewood, N.J., is immediate past chair.
